Many older adults not only embrace technology, they are charmed by it. Alexa, for example, has become a household name for many. And, in fact, some consider Alexa the most delightful roommate – demure, polite and ever so helpful.

Meanwhile, emergency alerts have been replaced with Apple watches that can track steps, blood pressure and emails

Older adults also manage their smart phones; they facetime with grandchildren and navigate Uber rides.

While many are quick to adapt to technology, the senior community is equally nimble in responding to the everevolving needs of the aging population. This is crucial because demographic studies of older adults indicate tremendous growth is on the rise. And with Medicare and Medi-Cal reimbursements at risk, providers are finding innovative ways to manage care by reinventing community-based services.

For instance, gone are the days of previous health care models, particularly in nursing homes where the length of stay was far longer than it is today.

Acute hospitals are discharging patients quickly, expecting nursing homes to provide post-acute care following heart surgeries, strokes, hip and knee replacements, etc. These stays serve to help elders gain strength before returning home, often with home care and home health services.

It is not uncommon for Seacrest's Goldberg Health Care Center to have 25-30 admissions a month, serving older adults requiring speech, occupational and physical therapies. This is the new normal for our health care center. Over the past year, it has been under contract with Scripps Health as a preferred provider. Patients can come from other hospital networks, too, so if you or someone you know may need post-acute care, please don't hesitate to call us. Also, be sure to tell the case manager at the hospital your choice is to receive your post-acute care at Seacrest's Goldberg Health Care Center.

If you've never been to Seacrest or haven't been in years, I urge you to pay us a visit. I'm sure, like me, you will feel a sense of pride that this incredible resource is here for our community.

Have questions about Medicare, home care, home health, long term care insurance, or any other aging concerns? Call us. It's all part of the incredible resource that's here to serve you!

Hillel, the great Jewish religious leader, sage and scholar, was born, according to tradition, in Babylon and lived into the first decade of the Common Era. Among the myriad pieces of wisdom attributed to him, there is possibly none that sums up so beautifully what he believed to be the mandate to the Jewish people; "Al tifrosh min ha zibur...do not separate yourself from the community."

Judaism is a religion steeped in a deep tradition of community and almost every part of Jewish life is done in partnership with others. Jewish worship takes place in a synagogue or other prayer space with at least ten people gathered together. There are, in fact, parts of a prayer service which are not done or must be recited silently if a minyan is not present, indicating that the ideal way to worship is in a group and not alone. Jewish study ideally takes place in a chevrutah, a partnership of two or more people who learn together in order to discuss, pull apart, and argue a text. Anyone who has ever walked past a yeshiva in Jerusalem recognizes by the decibel level of the conversation that serious community learning is taking place. Jewish lifecycle events, whether a wedding, Bar or Bat Mitzvah, funeral or Brit Milah, always take place in community, with many people in attendance in order to honor, remember, or celebrate. And perhaps one of the best examples of Jewish community happens during meals. It is certainly far more enjoyable to attend a large Pesach Seder or Chanukah party while eating in the company of others than it is to dine alone.

Having a supportive community, at every stage of life, is critical to one's physical, emotional and spiritual well-being, something which the great sage Hillel certainly understood. Life at Seacrest Village exemplifies this ideal of community in all that it does. Our residents worship with others, study in chevrutah, celebrate and mourn as one, and dine together daily. So much of this is made possible because of the involvement of the "greater" Seacrest community. Through the ongoing work of our dedicated staff, tireless volunteers, and generous donors, we are able to continue to offer a vibrant and award-winning community for San Diego's seniors. We are grateful that you are part of our community.

New Location, Same Vocation, and Other Contemplations

Humans are social creatures, seeking the comfort and warmth that comes with an honest, inter-personal exchange. Lately, all of Seacrest at Home's staff are feeling this love, as in late December we completed our relocation from the tranquil Stein Center in the southeast corner of the Seacrest Village campus to the bustling activity of the Lee & Frank Goldberg Residence Court. As you know, our caregivers serve many residents throughout the Seacrest campus. Now, management staff can also enjoy the delightful daily interactions our caregivers and the Seacrest Village staff have enjoyed all along. It's not only personally enriching, but also serves as good word-of-mouth marketing for the many services we provide as we chat with residents and their families when they pass by, contributing to our continuous growth.

On that note, our requests for service never stops. We are up 62% in client inquiries from this time period last year. We're beyond proud of this fact given we set a very high employment bar, ensuring our caregivers are the kind of people we'd feel comfortable having in our own homes. Our caregivers are expected to exhibit professionalism and compassion in all that they do. We will never slacken our fastidious selection process, and we continue to identify unique hiring strategies to ensure we can serve all clients at the highest level possible.

I am pleased to share that Jewish Home Care Services, Inc, which has the dba Seacrest at Home, will soon have another dba, Seacrest Home Health. Our home health license has been approved, and, once the State's on-site visit is complete, we will be open for business. This couldn't come at a better time as it is estimated that the US home healthcare market is projected to grow about 7% annually from \$103 billion in 2018 to \$173 billion by 2026 — outpacing growth in all other care types, including hospital care (+5.3% annually) and physician services (+5.6% annually). Seacrest Home Health will be able to serve patients whose care requires physician orders for care services like wound care and medication prefills, while Seacrest at Home will continue to serve clients who are in need of assistance with activities of daily living and companionship.

As you can see, there is much positive activity with Jewish Home Care Services. We are excited for the opportunity to expand our services and be able to offer home health care to clients. We take great pride in being able to serve the residents on-site and out in the greater community as well, and I invite you to visit both our Seacrest at Home and Seacrest Home Health offices, now located in the Lee & Frank Goldberg Residence Court. And please tell your friends about us. If anyone you know is looking to maintain their independence, or is recovering from a surgery or injury, we can help.

A Formula for Creating Community, Staying Healthy, and Thriving

There is a unique formula for decisions around retirement: we subtract the responsibilities of work, and perhaps the duties of home ownership, and we add activities of leisure. For residents of Seacrest Village, the addition of an enriching environment makes for an easy decision to move to a retirement community.

Loss is an inevitable part of the aging journey. We lose family, friends, loved ones, independence, health, and even cognitive ability. Research suggests that the potential resulting feelings of loneliness pose significant health risks:

"Loneliness acts as a fertilizer for other diseases. The biology of loneliness can accelerate the buildup of plaque in arteries, help cancer cells grow and spread, and promote inflammation in the brain leading to Alzheimer's disease."

At Seacrest Village, we believe that the answer is not simply living in a retirement community but thriving in the *right* retirement community. "Our activities aren't designed just to keep residents busy," explains Marisa Rosenberg, Director of Life Enrichment at Seacrest Village. "We develop programs tailored to each level of care so that every resident is actively engaged with their peers and their community in a meaningful way."

With offerings ranging from outings to the symphony, seasonal visits to neighboring San Diego Botanic Gardens, to a journey through the prayer book, Seacrest provides vital opportunities for residents to share their knowledge and explore emotions, key interventions in combatting loneliness.

Before joining the Seacrest Family, one of our newest residents lived less than 10 miles away. While the physical distance she moved seems insignificant, the transformation in her quality of life was



remarkable. Despite weekly card games, and visits with local family, she felt lonely. The loss of her spouse and isolation in her empty two-story house of three decades was overwhelming.

Since moving to her one-bedroom apartment at Seacrest, she has made new friends, enjoyed stimulating activities, and — perhaps most importantly — observed a remarkable increase in feeling "connected" and part of a caring community.

Your support empowers our residents to overcome loneliness, and we have many opportunities to get involved. Whether you contribute to Seacrest Foundation to ensure that outings are available to all, or volunteer your time in our community, you directly impact and improve the lives of our Seacrest family!

Pump the Brakes

Give your aging adult's driving skills an inspection

Let's face it. As we age, some things just become harder to do. Bending, stretching, lifting, running, walking, and climbing — our mobility and reflexes decrease with time. While the aforementioned activities affect only the individual doing them, other activities that are impeded by decreased mobility can cause harm to others — the most significant of which is driving a car.

It's how we get from point A to point B, but it's also representative of independence. Therefore, when the time comes to take the keys away, it should be done with respect and with candor about the liability and injury seniors could face. Combined with diminished hearing and vision, slower reflexes can turn driving into a very dangerous activity. So, if you know of a senior who may be getting to this point, here are some tips:

Keep vigilant for things like:

- gas pedal/brake confusion
- lifting the whole leg (instead of just the foot) to switch between pedals
- ignoring or missing stop signs and other traffic signals
- lane straddling
- slow driving that impedes others (people honking or trying to get around the senior's vehicle)

If you do notice these things:

- start a conversation early before someone gets hurt (AAA has some great resources for getting the process going)
- propose slight amendments to their driving privileges at first (daytime driving or for short trips only)
- avoid an intervention (don't bring the whole family to discuss)

It's Saturday morning, and I am sitting in Torah Study at Congregation Beth Israel. I had never been to Torah Study until my mother passed away, one year ago. It's a new experience, and I'm not quite so comfortable with my own knowledge base as others share their perspectives and commentary on this week's Torah portion. The intimidation factor grows when I realize that on this particular day seven of the 25 people with whom I am studying have parents or relatives currently residing at Seacrest Village. Great, I thought. I will for sure appear to know not a thing besides philanthropy to these people who know me. My cover is blown: I work for a Jewish agency, but my knowledge of Torah is so limited. My reason for being here is good. I am here with the love of my mother's life. She unexpectedly passed away but was blessed by God to have spent the last two years of her life with the man who completed her. So to honor both of them, and because I love spending time with him, I joined the Saturday Torah Study group.

Going around the room taking turns reading the passages, I quickly count ahead to see which portion I will be expected to read. I make sure I know how to pronounce each word (try it, we have some very challenging words in our Torah). There are seven people ahead of me, and my turn is getting closer. And then, just as it's about my turn, I am blessed (and I mean blessed) as the Rabbi moves on to another discussion. I'm free—no reading—well, at least until next week.

Another blessing befalls me as Rabbi continues. The topic becomes "Rituals." Home run—I get this topic. I grew up with a mom who had a million rituals, and we have so many of them at Seacrest Village and Seacrest Foundation. My mind begins to wander. Ok, I'm ready. If Rabbi glances my way, I have something to say. I begin to think of all the Seacrest rituals. First, all new residents and family members go through a resident orientation. All staff also go through an operations orientation, learning about Jewish holidays, customs and the laws of kashruth. Then there's the celebrating of each resident's birthday, which leads me to think about the rituals of taking care of the residents' and families' physical and spiritual needs. Seacrest has a "no one passes alone" ritual. Everyone is surrounded by love and comfort as they pass. When family members are not present, Seacrest becomes the family. Indeed, when my own mother, my best friend, passed away suddenly in her beautiful Seacrest apartment last February, it was one of the worst days of my life, but thankfully, the Seacrest rituals were in full force. Within 60 seconds of my call to a colleague, the hall in front of Mom's apartment was filled with staff members and other residents. What ritual was that you may be wondering—the ritual of taking care of one another no matter what—the ritual of showing up. On that day which is indelibly etched into my memories, the Seacrest rituals provided my family the support we had no idea we needed. What then followed within moments were calls from our San Diego Rabbis and my colleagues from other Jewish agencies—another ritual—as Jewish Communal Professionals we have a unique bond to help one another. I quickly become aware that I'm still in Torah Study... but I haven't yet been called upon to offer a comment. I can continue thinking while attempting to pay attention.

My thoughts turn to Seacrest Foundation. We have one ritual after another. As colleagues we celebrate each accomplishment and milestone as we grow the work of the Foundation, but of utmost importance is the way we seek to honor each gift that arrives and the contributor who made the gift. At Seacrest Foundation we have one board member who has, for years, led a D'var Torah at the October Board Meeting. Each year we look forward to hearing David Ellman's words. This ritual is so meaningful, as David has been most important in the growth of Seacrest Foundation. And then there is the ritual of honoring those who came before us—honoring our fathers and our mothers. Which then leads me to think about the recent Gala of which Seacrest Foundation Board Members Sheila and Jeffrey Lipinsky were the honorary chairs. The Lipinskys have been instrumental in leading the way for San Diego Hebrew Homes and the Seacrest Foundation. What part of that is a ritual? The ritual of dor l'dor—generation to generation: Jeffrey and Sheila do this because their parents and grandparents did it and because...as we are taught...it's the right thing to do. Rituals. They are everywhere and make what we do somewhat predictable but also overwhelmingly meaningful. Ok, I have a lot of things to say, so call upon me Rabbi! I am ready to speak. I've got this topic.

Torah Study ends for the day. As we head into the minyan service, I realize I have a new ritual. That of attending Saturday morning Torah Study and then Saturday Morning Minyan with my dad, my mother's gift from God. Pretty cool ritual (and I didn't even have to read today).
